#### LOCATION

Darlington has an estimated urban population of 98,900 and a catchment of c. 240,000. It has been awarded £22.3m from the Government's Town Fund to extend regeneration projects.

Major retailers include House of Fraser, Next, Primark, River Island, Waterstones and B&M.

Retailers close by include F Hinds Jewellers, Lloyds Bank, CEX, Cigara, Hartbeeps Play Centre and Card Factory.

There is a **160-space surface car-park** to the rear of this covered centre.


