#### LOCATION

Darlington has an estimated urban population approaching 100,000 and a catchment in the region of 240,000. It has been awarded £22.3m from the Government's Town Fund.

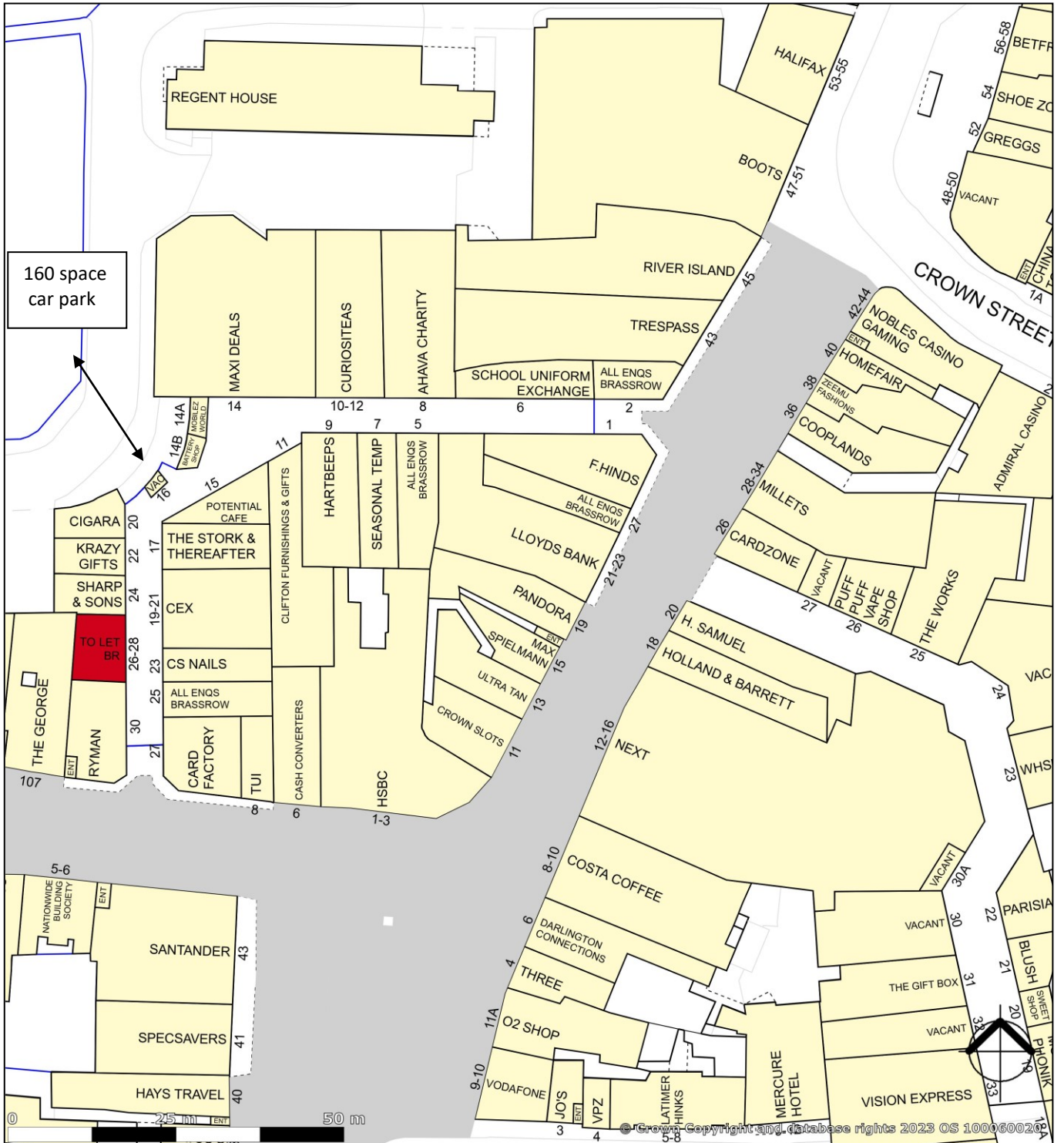
